# MEMBER PROFILE





Ron purchased his 1960 Corvette in the early 70s for \$175.00 and for work he had done on motorcycles for a friend. Of course the Vette did not look like it does today. It sat in his grandmother's yard until we bought our first house in 1976.

One of the requirements of our first house was that it had to have a garage for the Vette. The garage, however, was so small Ron could not work in it. Our second house did not have a garage but plenty of room for one. So, in a long weekend (once the foundation was poured) Ron and his brothers constructed a garage for the Vette. Then the fun began. He started searching for and ordering parts. For many years Christmas shopping for Ron was easy, he would just circle parts he needed in catalogues and I would just pick up the phone.

Slowly from 1980 to 1990, the transformation took place. The body came off the frame, Ron sandblasted it and he re-built the Vette from the ground up. Other than some bodywork, leather and the paint job, Ron did all the work himself. The car was painted in 1992. Ron chose the original color of Hondorus Maroon but when the paint began to dry, it faded and the car looked like it had zebra stripes. So it was repainted the Torch Red it is today.

The first show we attended was The Dobles Chevrolet & Gate City Corvette Club Show (long before we became members) on May 22, 1993 and Ron won his first trophy for the "Oldest Corvette".

As our girls became teenagers, with teenage boys wandering around and drooling over the Vette, and with little time to play, the Corvette went into storage, literally behind a wall of sheet rock in the garage. It remained there for about 5 years. Then slowly the Vette came to life again.

We joined the club in 2002 and have been enjoying the car and all the new friends we have made. In 2004 Ron completed the car with a hard top he purchased in Carlisle, PA.

Of course, being 45 years old, the car does get a bit temperamental at times and refuses to cooperate. It likes to be pampered with a ride on a flat bed from time to time, which recently has earned it the "Flatbed Trophy".

#### Section 3 – Dues

- C. Active Annual dues shall be as follows:
  - Single membership = US stamp rate X 100
