

## Yet Another Lawsuit Filed Over C7 Corvette Z06, Grand Sport Rim Issues

Yet another class action lawsuit has been filed against General Motors alleging the factory rims on 2015-2019 Corvette Z06 and Corvette Grand Sport models are prone to pressure cracks and other damage.

According to The Detroit Free Press, a new class-action lawsuit has been filed seeking compensation for 18 separate C7 Corvette Z06 and Grand Sport owners and lessees, plus all others who either purchased or entered a lease agreement for either one of the vehicles in the United States.

The lawsuit, like others that have been filed over this same issue, alleges the factory rims on certain C7 Corvette model variants were manufactured using either substandard materials or faulty methods, making them prone to cracking and warping. The suit also notes that GM used inferior material than usual to reduce the unsprung weight of the wheels on these high-performance vehicles, further contributing to their alleged fragility.

The suit goes on to note that the wheel material is "cast, rather than forged, and is of insufficient strength, and in an insufficient quantity, to withstand the torque and power input from the drivetrain." The C7 Corvette Z06 produces 650 horsepower and 650 pound-feet of torque from its supercharged GM 6.2L LT4 V8 engine, while the Grand Sport and its naturally aspirated 6.2L LT1 V8 make 460 horsepower and 465 pound-feet.

GM will not replace the damaged wheels under warranty, the lawsuit also states. GM did offer an optional wheel and tire protection package with the C7 Corvette Z06 and Grand Sport, The Detroit Free Press points out, which cost an additional \$1,000.

"Consumers regularly paid over \$900 per wheel to replace one cracked wheel with an equally defective replacement wheel," the suit says.

Corvette chief engineer Tadge Juechter said in an online forum previously that the pressure cracks can form due if the driver hits potholes and other deformities on the road, which can weaken the wheel and cause it to bend and warp over time.

"Since it is hundreds or thousands of miles after the damaging event, the driver often can't remember hitting anything that would justify a crack in the wheel," Juechter said in the post. "I have actually experienced this myself."

An affected owner that spoke to The Detroit Free Press said he took his case against to the Better Business Bureau and won, with GM forced to reimburse him the \$4,940 that he paid out of pocket to fix the car's cracked OEM wheels. The arbitrator in that judgment said GM admitted that "minor depressions" at "low speeds" could cause the wheels to bend.

Vehicles included in this latest class action lawsuit span the 2015 to 2019 model years and include the C7 Corvette Z06 and Grand Sport only. A lawsuit was previously filed over this exact same issue back in early 2019, while a second similar lawsuit was filed earlier this year as well.

## Rumor: C8 Corvette Grand Sport to be Replaced with "E-Ray" Hybrid

Chevrolet has built Grand Sport versions of the C2, C4, C6, and C7 Corvette. Those last two 'Vette generations have used the engine from the base model, albeit fitted with a dry-sump oiling system and squeezed inside the wider bodywork of the Z06. It's a great combination that adds road-holding grip and great looks with more than enough power for most enthusiasts to handle. However, if you were holding out on ordering a C8 Corvette until the Grand Sport debuts, you may be out of luck. According to *GM Authority*, the Grand Sport isn't happening and a hybrid "E-Ray" Corvette will take its place.



1996 Grand Sports are among the most collectible C4 Corvettes. It has long been speculated that Corvette would offer at least one variant that ditches its frunk to add an electric motor to drive its front wheels, and we've known about the E-Ray moniker for years. The C8's large center tunnel, which helps with chassis rigidity, turns out to be a good place for batteries.

The performance-focused E-Ray could add another 100 or so horsepower to the already stout output of the 6.2-liter LT2 V-8, which cranks out 495 hp when equipped with the dual-mode exhaust. An even more powerful variant, "Zora", would combine the higher-output Z06 powerplant with a hybrid drivetrain to make the ultimate C8.

We're not sure when the E-Ray would hit the market. If it can be seen as a mid-level performance package like the Grand Sport, we would expect it to follow the Z06. The Grand Sport, as great a package as it has been, lately served to keep up interest in the Corvette as the generation aged. Chevrolet is going to build 2020 Stingrays into December to keep up with orders for the initial year of C8s, in part due to shutdowns related to COVID-19. In fact, Corvette's Bowling Green assembly plant is shutting down the week of October 12 due to a supply-related issue that sprang up because of the pandemic.

Despite the setbacks, it seems as though Team Corvette is not slowing down when it comes to developing even more impressive C8 variants.





## 2020 Chevy Corvette Now Getting Zora Graphic on Windshield

#### There's also a Team Corvette logo on the glass





If we've learned anything about Corvette owners through the years, it's that they enamored with neat little details. Now, there's a new detail for 2020 Corvette owners to get excited about. Or rather, 2020 owners getting their cars late in the run might get excited. Early C8 buyers might simply get jealous.

Look closely at the windshield of late-run 2020 Corvettes and you'll see a man's head on the lower passenger side corner, with Team Corvette showing up on the driver side corner. This discovery was recently made by Kerbeck Chevrolet in New Jersey on a recently delivered C8. Kerbeck is the largest Corvette dealer in the world so they see fresh 'Vettes on a regular basis and this new Easter egg was found on the highest-VIN model they've seen thus far.

We were curious about this addition and contacted General Motors to ask about it. A spokesperson confirmed that it's something recently added to the C8, and it will appear on all Corvettes going forward.

Of course, the small head is the likeness of Zora Arkus-Duntov. Widely regarded as the Father of the Corvette, he injected serious performance into the C1 and C2 models during his GM tenure, and fostered the original idea for a mid-engine version of the sports car. It would be over a half-century until his vision was finally realized in a production model, and Chevrolet is certainly keen to give credit where credit is due. We saw Zora's likeness incorporated into the camo wrap of C8 test vehicles, and the ultimate version of the C8 with 1,000 horsepower is expected to carry his name as the Corvette Zora.

Perhaps a bigger question now is, how will Corvette enthusiasts take to the early C8s not having this Zorabranded windshield? We suspect there will be owners coveting the windshield for sure, but knowing that it will be offered on all Corvettes going forward, the early-production cars could get a neat bump in collectivity similar to the split-window C2 from 1963. Ultimately, only time will tell the tale.


I will send out a reminder for each meeting with the connection details.

### SARAH JOSEPHA HALE

# The 19th-century New Hampshire editor who pestered five presidents to make Thanksgiving a national holiday.

Sarah Josepha Hale was born Oct. 24, 1788 on a farm outside of Newport, New Hampshire, to Captain Gordon Buell, a Revolutionary War veteran, and Martha Whittlesay Buell. Her parents believed in equal education for both genders. Home-schooled by her mother and elder brother Horatio (who had attended Dartmouth), Hale was otherwise self-taught. Growing up, she hardly seemed likely to move a president, and influence a generation of Americans. She became a teacher, acclaimed writer, poet, activist, and the first American woman to serve as editor of a national magazine.



Sarah famously campaigned for the creation of the American holiday known as Thanksgiving. She wrote Presidents Taylor, Fillmore, Pierce, and Buchanan about it before finding success with Abraham Lincoln.

Of course, Thanksgiving had existed on these shores long before Sarah Hale took it up as a cause. Her description of a New England Thanksgiving feast in her 1827 novel *Northwood* would have been recognized by Norman Rockwell, and could apply with equal accuracy to the average American home today.

"The roasted turkey took precedence," she wrote, "being placed at the head of the table; and well did it become its lordly station, sending forth the rich odor of its savory stuffing, and finely covered with the froth of the basting."

The dessert course is almost as recognizable: "There was a huge plum pudding, custards and pies of every name and description ever known in Yankee land; yet the pumpkin pie occupied the most distinguished niche."

Thanksgiving had always been held in autumn, Sarah explains in the book, "the time when the overflowing garners of America call for this expression of joyful gratitude." But different states held it on different days, and the holiday tradition was strongest in New England. Sarah wanted to guarantee Thanksgiving's place in America's firmament by making it a national day.

Sarah understood the particular pull of Thanksgiving. She wrote in 1837, "It is a festival which will never become obsolete, for it cherishes the best affections of the heart — the social and domestic ties.

In a September, 28, 1863 letter to Lincoln, Sarah made the case that a "National and fixed Union Festival" should occur on the last Thursday of November, annually, because the last Thursday of November was when George Washington had declared the first national Thanksgiving in 1789. On October 3, Lincoln issued the

proclamation designating "the last Thursday of November" as a day of Thanksgiving, arguing in several newspaper editorials that, "in the midst of a civil war of unequalled magnitude and severity, the American people should take some time for gratitude."

In her 1852 editorial, Sarah had predicted that "wherever an American is found, the last Thursday would be the Thanksgiving Day. Families may be separated so widely that personal reunion would be impossible; still this festival, like the Fourth of July, will bring every American heart into harmony with his home and his country." And so it does, still.
